### Stqarrija: Il-Proposti tal-Kamra tan-Negoju għal Għawdex għall-Baġit 2020

Il-Kamra tan-Negoju għal Għawdex ħarġet b' numru ta' proposti għall-Baġit 2020. Dawn il-proposti ġew pprezentati fil-Gozo Regional Committee:

- Il-Kamra tan-Negoju għal-Għawdex ipproponiet li l-proġett tal-mina bejn Għawdex u Malta għandu jkompli.** Il-Kamra pproponiet ukoll li l-iskart iċċ-ġenerat minn dan il-proġett għandu jintuża għat-tkabbir tal-faċilitajiet tal-irmiġġ fl-iMġarr, Għawdex. Dan il-proġett madanakollu għandu jkun akkumpanjat minn pjan ħolistiċċu li jiżgura l-iż-żvilupp sostenibbli tal-gżira ta' Għawdex. Dan għandu jwassal biex il-lokalitajiet f'Għawdex jibqgħu distinti bejniethom u li l-karattru uniku ta' kull lokalitā jiġi ppreservat. Il-Kamra temmen li l-Outside Development Zones (ODZs) f'Għawdex m'għandhomx jintmessu. L-aċċessibbiltà trid tkun akkumpanjata minn pjan ta' żvilupp sostenibbli għall-gżira kollha kemm hi.
- Faċilitajiet ta' parkeggia aħjar biex jaqdu n-negożji fir-Rabat Għawdex.** Dan għandu jkun akkumpanjat minn pjan ħolistiċċu ta' gestjoni tat-traffiku. Proposta li tressqet mill-Kamra hi li jkun hemm multi storey parking facility taħt l-art.
- L-introduzzjoni tar-raba vapur fuq bażi permanenti.** Madanakollu għandhom ikomplu jiġu maħsuba soluzzjonijiet għall-operaturi kummerċjali Dan jista' jinkludi l-introduzzjoni ta' sistema ta' pre booking għall-operaturi kummerċjali. Din is-sistema għandha tiġi ntrodotta biss fuq vjaġġi ddedikati biss għal vetturi kummerċjali. Dan joffri lill-operaturi kummerċjali l-opportunità li jippjanaw aħjar l-attivitajiet ta' trasport tagħhom bejn iż-żewġ gżejt. Il-Kamra tinnota wkoll li jistgħu jiġi kkunsidrati aktar servizzi dedikati għall-vetturi kummerċjali biss.
- L-introduzzjoni ta' fast ferry service.**
- L-introduzzjoni ta' servizz ta' helikopter,** bi skeda li tkun allinjata mat-titjiriet ewlenin kollha, u bi prezziżiet li ma jiskora għixxu l-użu.
- Twaqqif ta' aġenziji li jikkumplimentaw ix-xogħol tal-Ministeru għal Għawdex.** Il-Kamra tinnota b'mod pozittiv l-isforzi biex titwaqqaf l-Awtorità għall-Iżvilupp Reġjonali ta' Għawdex. Il-Kamra hija tal-fehma li għandhom bżonn jitwaqqfu aġenziji specjalizzati biex jikkumplimentaw ix-xogħol tal-Ministeru għal Għawdex, bħall-'Aġenzija Kultura Għawdex, u t-twaqqif ta' aġenzija ffokata fuq l-iż-Żvilupp Ekonomiku. Il-Kamra tinnota b'mod pozittiv li żiddu n-numru ta' attivitajiet kulturali f' Għawdex. L-'Aġenzija Kultura Ghawdex għandha tkun responsabbli li tikkoordina b'mod ħolistiċċu dawn l-attivitajiet. Min-naħha l-oħra l-aġenzija għall-iż-Żvilupp Ekonomiku għandha:  
(a) tieħu ī-sieb ix-xogħol relatati mal-miżuri ekonomiċi f' Għawdex, għalkhemm tibqa' taħt ir-responsabilità tal-Ministeru għal Għawdex; (b) tospita one stop shop għall-entitajiet kollha relatati ma l-ekonomija f'Għawdex e.g. Malta Enterprise, Business First, Trade Malta eċċ ; u (c) tgħin lill-intrapriżi biex irawmu t-tkabbir ekonomiku permezz tal-parteċipazzjoni tagħhom f' konsorzi li jaapplikaw għall-proġetti tal-Unjoni Ewropeja.

- **Soċjetà Ċivili.** Il-Gozo Regional Committee fi ħdan I-MCESD għandu jkollu baġit allokat u rappreżentanza permanenti fil-gżira.
- **Il-Barts Medical School u s-Servizzi tas-Saħħha.** Il-Kamra tinnota l-iżviluppi požittivi fir-rigward tal-Barts Medical School. Il-Kamra temmen li għandu jkompli jkun hemm impenn qawwi fuq is-servizzi tas-saħħha f'Għawdex biex jiġi żgurat li jinżamm il-livell meħtieg ta' servizz. L-iżvilupp soċjali u ekonomiku ta' Għawdex jimxu id f'id u servizzi fil-komunità b'saħħithom speċjalment fis-setturi tas-saħħha se jiżguraw li Għawdex ikompli jimxi fid-direzzjoni t-tajba. L-iżvilupp tas-setturi tas-saħħha f'Għawdex għandu jitqies ukoll f'perspettiva holistika. Minbarra I-Barts Medical School, wieħed għandu jikkunsidra wkoll qasam ta' speċjalizzazzjoni li Għawdex jiġi eventwalment jiffoka fuqu fis-setturi tas-saħħha.

- **The University of Malta Gozo Campus.** Il-Kamra temmen li għandu jerġa' jiġi maħsub ir-rwol strateġiku ta' dan il-post bit-twaqqif ta' fakultà speċjalizzata fil-Kampus ta' Għawdex u b'korsijsiet li jiġi offruti biss minn dan il-post.

## **Press Release: The Gozo Business Chamber's proposals for the Budget 2020**

The Gozo Business Chamber, has presented a number of proposals for the upcoming budget 2020. These proposals have been presented within the Gozo Regional Committee:

- **The continuation of the project of the subsea tunnel between Gozo and Malta.** The Chamber also proposed that the waste generated by this project should be used for the enlargement of the berthing facilities in Mgarr, Gozo. This project however should be accompanied by a holistic plan ensuring the sustainable development of the island of Gozo, such as for example that the green belts between localities are retained, and that the unique character of each locality is preserved. The Chamber believes that the present Outside Development Zones (ODZ) in Gozo should not be touched. Accessibility needs to be accompanied by a sustainable development approach.
- **Better parking facilities to serve Gozo's retail facilities in Victoria,** accompanied by a holistic traffic management plan. An underground multi-storey parking facility for Victoria should be considered.
- **The introduction of the fourth ferry on a permanent basis.** Solutions for commercial operators however should also be envisaged. This may include the introduction of a pre-booking system for commercial operators on trips dedicated only to commercial vehicles. This would offer commercial operators the opportunity to better plan their transportation activities between the two islands. The Chamber also notes that more dedicated services for commercial operators may need to be considered.
- **The introduction of the fast ferry service;**
- **The introduction of a helicopter service,** with a schedule which is aligned to all major flights, and with pricing that does not discourage usage.
- **Setting up of agencies which complement the work of the Ministry for Gozo.** The Chamber positively notes the endeavours to set up the Gozo Regional Development Authority. The Chamber is of the opinion that specialised agencies need to be set up to complement the work of the Ministry for Gozo, such as 'Aġenzija Kultura Ĝħawdex', and the setting up of an economic development agency. 'Aġenzija Kultura Ĝħawdex' would be a dedicated cultural agency that would ensure a holistic set-up and coordination which is required given the substantial number and calibre of events that are taking place in Gozo. On the other hand an economic development agency would: (a) take over the work related to economic measures of the Ministry for Gozo but would still be answerable to the Ministry; (b) host a one stop shop for all the entities related to the economy in Gozo e.g. Malta Enterprise, Business First, Trade Malta etc.; and (c) assist enterprises to foster economic growth through participation in EU projects and consortia.
- **Civil Society.** The Gozo Regional Committee within MCESD should have an allocated budget and a permanent representation on the island.
- **Barts Medical School and Health Services.** The Chamber notes the positive developments with respect to the Barts Medical School. There should continue to be a strong focus on health services in Gozo to ensure that the required level of service is maintained. Community and economic development are interlinked and strong community services especially in the health sector will ensure that Gozo will continue to progress in the right direction. The development of the health sector in Gozo should also be seen in a holistic perspective. Apart

from the Barts Medical School one should also consider an area of specialisation which Gozo could eventually focus on in the health sector.

- **Extension of Existing Schemes**, such as the reduced stamp duty for properties purchased in Gozo should continue to apply.
- **University of Malta Gozo Campus**. There should be a strategic rethinking of the Gozo Campus with the setting up of a specialised faculty at the Campus with courses which will be offered only from Gozo.
